Export	Demurrage Free Time	ALL trades/locations	Demurrage free time starts as from actual day of delivery at the terminal. Export demurrage free ends the actual loading date.
Export	Demurrage Charge	ALL trades/locations	It shall be accumulated from the first day when demurrage free time expired. The charge will be settled with MOL.
Export	Detention Free Time	ALL trades/locations	Detention starts as from pick up day at empty terminal/depo.
Export	Detention Charge	ALL trades/locations	It shall be accumulated from the first day when detention free time expired. The charge will be settled with MOL.
Import	Demurrage Free Time	ALL trades/locations	Demurrage free time starts to count from the day of discharge at the terminal
Import	Demurrage Charge	ALL trades/locations	It shall be accumulated from the first day when demurrage free time expired. The charge will be settled with MOL.
Import	Detention Free Time	ALL trades/locations	Detention freetime starts to count as from the next day of pick up cntr from terminal
Import	Detention Charge	ALL trades/locations	It shall be accumulated from the first day when demurrage free time expired. The charge will be settled with MOL.
