From January 2015 MOL Liner engages in full compliance in the implementation of new Low Sulphur Fuel Policy set by the International Maritime Organization (IMO) in which the new policy requires every ship operating within the Emission Control Areas (ECAs) to use fuel with a maximum allowed sulfur content of 0.1% (current limit: 1.0%). As low sulphur fuel is significantly more expensive than standard heavy fuel a Low Sulphur Surcharge has been introduced to recover the additional cost which is the result of us complying with the new IMO fuel policy.  
-The Low Sulphur Surcharge levels are reviewed on a quarterly basis.
