Export	Demurrage Free Time	ALL trades/locations	Free time shall commence from the first midnight after the loaded container has been returned to Carrier's facility.
Export	Demurrage Charge	ALL trades/locations	Demurrage shall be calculated from the first midnight following expiration of free time and all cease two days before a vessel's arrival at the first loading port in Taiwan, Saturdays, Sundays and Holidays included.
Export	Detention Free Time	ALL trades/locations	Free time shall commence from the first midnight when equipment release from carrier's facility.
Export	Detention Charge	ALL trades/locations	It shall be calculated from the first midnight following expiration of free time.
Import	Demurrage Free Time	ALL trades/locations	It shall be counted from the first day after the last container move into terminal.
