Export	Detention Charge	ALL	Detention charge will be accumulated immediately after the free time expires. The charge shall be settled with MOL.
Import	Demurrage Free Time	ALL	Start counting from the day after container discharge(Sundays and holidays during the period of free time are excepted).
Import	Demurrage Charge	ALL	Demurrage charge will be accumulated immediately after the free time expires. The charge shall be settled with MOL.
Import	Detention Free Time	ALL	Detention free time start counting from the day after container is gated-out from each port or CY (Sundays and holidays during the period of free time are excepted)
